THE HERTFORDSHIRE (TEMPORARY TRAFFIC MANAGEMENT MEASURES ON VARIOUS ROADS IN HUNSDON, STANSTEAD ABBOTS AND EASTWICK) ORDER 2019

NOTICE is given that the Hertfordshire County Council intends to make an Order under Section 14(1) of the Road Traffic Regulation Act 1984, the effect on the following lengths of roads ("the Roads") will be:-

- 1. To prohibit all traffic from using the following lengths of Roads and to prohibit all vehicles from waiting at any time on both sides of these lengths of Roads whilst works are in progress:-
- a) that length of Church Lane, Hunsdon from its junction with A414 Eastwick Road north westwards to its junction with Hunsdonbury Lane, a distance of approximately 1782 metres.

An alternative route will be via A414 Eastwick Road, A1170 (Pepper Hill/Amwell Hill/ London Road/Viaduct Road/Bridge Foot), B1004 (Star Street/Widbury Hill/Ware Road), B180 (Hunsdon Road/Widford Road/High Street) and Acorn Street.

b) the central reservation situated on the A414 Eastwick Road, Stanstead Abbots/ Eastwick from a point in line with the western kerbline of Church Lane south eastwards for a distance of approximately 52 metres.

An alternative route will be via Church Lane, Acorn Street, B180 (High Street/Widford Road/Hunsdon Road), B1004 (Ware Road/Widbury Hill/Star Street), A1170 (Bridge Foot/ Viaduct Road/London Road/Amwell Hill/Pepper Hill) and A414 Eastwick Road.

2. To prohibit all vehicles from making a right turn manoeuvre from Church Lane, Hunsdon into the westbound carriageway of A414 Eastwick Road, whilst signs are in place.

An alternative route will be via A414 Eastwick Road, the Eastwick Road/A414 Fifth Avenue roundabout and A414 Eastwick Road.

3. To prohibit all vehicles from making a right turn manoeuvre from the westbound carriageway of A414 Eastwick Road, Eastwick into Church Lane, whilst signs are in place.

An alternative route will be via A414 Eastwick Road, A1170 (Pepper Hill/Amwell Hill/ London Road/Viaduct Road/Bridge Foot), B1004 (Star Street/Widbury Hill/Ware Road), B180 (Hunsdon Road/Widford Road/High Street) and Acorn Street.

The Order is needed because works are proposed to be executed on or near the Roads.

If the Order is made, it shall come into force on 4 February 2019 for a period of up to 18 months. However, the restrictions specified shall only take effect at the times indicated by signs on or near the Roads.

A copy of the proposed Order may be inspected free of charge at County Hall, Hertford between the hours of 9.00am and 5.00pm (excluding weekends, bank and public holidays).
